It's about Trust

This week has been a very busy week for the Federation Committee who had to prepare a submission for the Government Administration

Committee.

This Government Select Committee were tasked last week with reporting by 22 March to the House of Representatives regarding the Plumbers, Gasfitters and Drainlayers Amendment Bill.

Not only did our Committee meet the

deadline they also appeared and gave evidence at the Government Administration Committee Hearing. The Editor, on behalf of the Federation members, wants to thank the committee members who have put in a huge effort to get our point across at the hearing. We also want to thank those members who submitted written submissions to the select committee.

We know the submissions and lobbying had an effect as it was announced on Wednesday during the hearing, that the Select Committee had been given an extra two weeks to consider the Bill.

So just to recap a bit, the Bill seeks to validate decisions made by the Plumbers Gasfitters and Drainlayers Board and the Minister of Building and Housing, and also amends the Act to give the Board power to levy the industry for prosecutions of non registered people. It attempts to make the illegal - legal.

Given that industry fund the Board through their fees, many plumbers, gasfitters and drainlayers are becoming increasingly disaffected and feel it is vital that the Board uses its statutory powers properly to gain the trust and respect of the industry. The actions taken by the Minister will not aid in the Board's quest to gain credibility at all.

The Federation Committee members who attended the Select Committee Hearing have informed us that all went well and that it was good to see Master Plumbers partly supporting the view of the Federation. We have often said there is common ground but no one has ever wanted to sit around a table with us to pave a way forward. Perhaps the hearing was a starting point for a more productive relationship with Master Plumbers and their new CEO.

We think the word is "arrogant".

We spoke with Colleen Upton, the Federation's Secretary who stated the industry has a lot going for it and both industry organisations have their place.

She is supportive of getting both organisations together to correct the wrongs in the industry – it would indeed be hard to ignore such a group.

Colleen said "It won't be an easy task as there is a lot of ingrained resentment and old views but times are changing and we all need to change with them".

For the Federation we need each member to go out and get one new member and before you Alan Day senior was his normal composed self and got some very valid points across during questioning. Wal Gordon opened confidently and certainly ensured that we got our points across to the Select Committee, and indeed the members of the public and interested parties that attended.

So at this stage there is not much to tell except that the Government Administration Committee did listen, they questioned and seemed to have a good grasp of the issues in front of them. They were also not afraid to step outside the scope of their inquiry to get information and answers.

Time will tell, but they have invited the Federation and others that gave evidence to send in additional information and views - so if YOU have any views or points you want us to raise then please send them to us before Monday 25 March 2013.

What \$600,000?

The Ombudsman in a recent report stated the Board were wrong with regard to the offences fee and suggested they return over \$600,000 to the industry.

It was reported this week that Maurice Williamson thumbed his nose at the Ombudsman by refusing to refund to plumbers, gasfitters and Drainlayers, hundreds of thousands of dollars in illegally gathered industry levies.

The Ombudsman recommended that the Board should negotiate an arrangement "whereby the excess levies paid could in whole or in part be refunded over a period or some credit could be given in respect of future fee or levy payments in compensation".

It would appear Mr Williamson dismissed the Ombudsman's recommendation and claimed the Board would be technically insolvent if they had to pay this money back.

Legal Action

We are not getting complacent about current events and our preparation for legal action will continue.

We have touched base with Chen Palmer who are New Zealand Public and Employment law Specialists and have explained our intentions to them if Maurice Williamson's Bill goes through.

If we have to go to court we will, and it will mean we will all have to dip into our pockets to take a class action against the Board.

While on the subject of money, don't forget we operate on donations so if you wish to help out and invest in the future of the industry make a donation.

Every little bit counts so if you want to make a donation you can either send a cheque made out to the:

Plumbers Gasfitters and Drainlayers Federation,

or

Make a direct deposit at any National Bank, deposit on line through internet banking or set up a month Construction, and the Plumbers Gasfitters and Drainlayers Board.

This week the Minister put a Bill before Parliament that, if passed would make legal the actions of the Board that have been unlawfully taking money from plumbers, gasfitters and drainlayers.

The Bill which is being rushed through Parliament in one week, has the effect that the Board cannot be required to refund the monies collected by the Board unlawfully (\$1.8 Million plus over three years)

The Minister continues to support the Board which he appointed.

If the number is unknown then the system will advise for Auckland press 1 for Wellington press 2 and so on. Option 1 will be diverting to product inquiry that will be handled by our office, also in this case if an installation is required all inquires go to members.

They are not looking at profiting from this and are looking more towards a support system that can work nationally and laying a foundation for a larger vision. The costs involved would be the purchase and setting up of the server plus ONLY the call usage going to the members plus any extra's the members wish to have (example: special answering message if not available).

They are happy to provide original quotes and bills to our members. This will not only support the public but also Plumbers.co.nz members nationally.

Requirements

Interested people must be able to offer the following:

- Must be qualified and able to service Plumbing, Gasfitting and Drainage (Central Heating and Solar is an advantage).
- Must have a land line that will be answered during business hours and a mailbox or call centre after hours.
- Must reply to enquiries and complaints within a reasonable amount of time.

They will offer a basic agreement outlining responsibilities and duties (MOU) protecting them and our members.
