The Federation has a current balance of \$13,127.07, all of which has come from donations. Expenditure is being kept to a minimum, mainly photo copying, postage and electronic mailroom costs. A HUGE thanks is extended to those making regular donations ranging from \$5.00 to \$100.00 a month. The books are now being submitted for tax purposes as we are not a Registered Charity like the Board.

Membership is currently at 1030. This handful of "malcontents" as Flip Flop Williamson referred to us seems to be growing but we still need all members to get the word out to others. We've been challenged on our membership – but the proof of our numbers lies in our voice and our actions. Members have been good about responding to requests and for supporting submissions etc – perhaps more so than other organizations in the sector. The proof is evident when you got through the submitters for various things that the Board has called for – the Federation members are often around 70+ % of respondents.

154 issues of the Fellow Practitioner have been sent out and feedback is excellent. Thanks to all those who contribute, and just a reminder to everyone to send in your thoughts and ideas. Spelling and grammar don't matter - that's why we have a proof reader and editor to tidy things up.

It was reported at our workshop that nothing had been received from the High Court regarding the Board's Charity appeal. It was discussed and felt that this could take some time. The decision could have wide ranging effects on other charities.

No change to Continuing Professional Development, it's still a "buy points" scheme and the Regulations Review Committee has not reported on our requests for a review of our complaints.

Gas Certification was briefly discussed with regards to the impact on consumers and it was agreed the new process is a step backwards

The aim and values of the Federation were read and confirmed. It was agreed no changes were needed and the Federation had kept to the aims and values over the last two and a half years and should continue to do so.

The Chairperson's role was discussed and it was agreed the existing Chair should remain. Wal Gordon had offered to step down if anyone wanted to take on the role of Chairperson of the Federation. We will look at change as and when required. (Note from the man with the Ute, the cellphone and the dog – A big thank you to Wal from members – he has spent many hours championing our cause and he's done a fantastic job!)

A good discussion was held around membership recruiting and the application of an annual membership fee. With regard to fees it was felt that practitioners' circumstances varied and as such we should rely on people paying a small donation as they can afford it. We would like to encourage everyone to pay \$5.00 per month as a donation. Just set up an automatic payment through your bank. One big question is "what do I get for my money?"- the response is "what will you get if we don't hold the Board and Government accountable?" We again reassure members that no committee member takes any payment for meeting attendance, travel to various meetings or reimbursement of any kind; we even pay for our own sausage rolls!

We believe these actions by the Government and Parliamentary Committees is a breach of our right to natural justice. Bureaucratical tactics to wear people down in the hope people go away.

All it is doing is creating more work as now the Federation is exploring submitting complaints against those whom are not doing their jobs. For example the Regulations Review Committee who have had sufficient information to make decisions since November last year and have done nothing.

It is disgusting when the public are funding organisations and a parliamentary process that is failing.

Fight for your money



Last week we looked at a 1:6 ratio which showed us what turnover was required to fund activities of the Board - it worked out that for every \$100.00 we spent on Board activities it would take \$600.00 of turnover to break even.

Let's look at it for our annual licensing:

The Prosecution Fee of \$90.00 x 7100 practitioners licensing is \$639,000 paid to the

The state of the website was discussed as it was identified there had been no change since it had been started. Two of the committee members are happy to take over the updating of the website. Doing a video with a link was also discussed.

The Amendment Bill and the current consultation were discussed, as was the next steps for the Federation. It was agreed that we shouldn't wait for outcomes any more, that we should just push on to the next project and not let the Board or Government use the system to slow down progress.

Follow up letters are to be sent to the RRC regarding CPD, Fees and any other complaints that are in. It was agreed the Government was too slow and perhaps they should be bypassed and we go direct to the District Court for legal process. Costs and procedures will be looked at as will the need for legal representation, hence the reason or donations and fundraising.

It was agreed that the IRD should be approached and a determination requested regarding the payment of Offences fees and Disciplinary levies being a tax deductible item by practitioners who are employees.

Various forms of protest action were discussed and it was agreed that we need to ensure the protest action at licensing time next year should be looked at to ensure it is legal and will not put practitioners at risk. While the Board has acted illegally we don't want to lower ourselves to the same level. The possibility of prosecuting the Board under the Act was touched on and will be explored when legal counsel can be secured.

The Office of the Auditor General follow up investigation was discussed and the 15 recommendations they had made in their last report were read. It was agreed that the issues should be looked at more closely and any relevant documentation sent to the Committee Secretary for inclusion in a register of issues ready for the OAG. The review of the Plumbers Gasfitters and Drainlayers Act 2006 is scheduled to happen this year. We will keep a close eye on this and what the Board is recommending.

Do we need a Board? This question was discussed and the answer lays in what other options we have. It was mentioned that the Treasury Guidelines state that if something can be privatised then it should be. This will be investigated further.

The future of CPD was discussed and it was agreed we should start to look at what the Federation can do for members if we can't beat CPD legally. The development of courses to be provided to members free was discussed. An outline is to be developed.

The question was asked what the future of the Federation was and

Board which will require \$3,834,000.00 in turnover across the industry.

The discipline levy of \$175.00 x 7100 practitioners is \$1,242,500.00 paid to the Board will require \$7,455,000.00 in turnover.

The licensing fee of \$101.00 x 10,500 licences is \$1,060,500.00 paid to the Board will require \$6,363,000.00 in turnover.

All up just for discipline, prosecutions and licensing we are having to turnover \$17,652,000.00 as an industry just to pay the \$2,942,000.00 the Board steals from us.

The profits from the turnover could be better spent than on a failing Board.

It just doesn't make economic sense. How is that supposed to increase productivity by 20% which is what the Government wants.

And don't forget the price of sitting an exam, \$410.00, \$2460 in turnover.

To employ an apprentice you would be looking at apprenticeship fees \$10,580 x 6 = \$63,480 in turnover and 72 weeks of labour to cover the 12 weeks of assessments they attend so where is the incentive?

We need to force change to get ahead.

should we start to offer benefits for our members? It was agreed that the committee should look at this further once we tidy up our membership so we are not giving out false expectations. We are also interested in your views on this? What do you want from your committee? Do you want to see Chapters formed around the country to enable you to meet with other local practitioners; do you want to explore buying options, or benefits? We have kept our focus narrow and to the point – but in the end we are here to represent you and what you need.
